Call to Order

President Newbore called the May 4, 2021 meeting to order at 2:00 pm. President Newbore stated that the meeting was to convene following the Coronavirus Resolution passed on April 7, 2020, regarding audio conferencing for board meetings. President Newbore welcomed eleven guests who joined the meeting via audio and video conferencing.

Review of the Agenda: No changes were made to the agenda.

Approval of Meeting Minutes

Standing Committee Reports

Treasurer

Director Anderson presented an update of the Treasurer's Report. The report informed the board and the residents watching the live stream that the RV Lot, Marina, Tennis, Fitness Center, CCE, and Clubhouse are in good financial shape.

Activities

Property Management

Rick Schram delivered an update on the clean-up of tree debris impacted by the ice storm. Plans for reopening pools on May 15 with guidelines are in place.

Tennis Club

Kathi Gray presented updates on Tennis Club highlights.

- The tennis club has a board vacancy and is actively looking for tennis members to fill that vacancy.
- While many are interested in the board vacancy, none are Charbonneau residents.
- A subcommittee that enables nonresident tennis players to get involved could be a potential solution.
- The tennis club will present further updates on the topic at next month's meeting.

Village Center Development Task Force

Golf Club Liaison

Director Gibbons provided a verbal report. In addition, he highlighted the following notes:

- Further discussion with the Golf Course will determine future planning for the clubhouse.

Marina Parking Lot

President Newbore presented a verbal report following up on the work session discussion for the marina parking lot.

He provided the following list of steps that would take place in increments of the project proposal.

He provided a recommendation that includes taking the project up through the design process.

Board Action: The motion was seconded and the motion to begin the Marina parking lot process was approved unanimously.
