### **Emergency Preparedness and Safety Report:**

Safety Coordinator Neil Kennedy reported on suspicious activity in the community. Neil met with ODART (Oregon Disaster Airlift Response Team) earlier in the week to learn about how Aurora airport pilots assist small, isolated communities like Charbonneau in case of an emergency. Director Bubba Heard reported there will be an EPPS training on May 7<sup>th</sup>, involving MTRs and key captains to test the new radios. He will be presenting the public safety charter that the committee has been working on at the July board meeting. Bubba also announced that Tracy Meyer will be stepping down from the committee and we wish her the best.

# **Architectural Control & Landscape:**

Vice President Kathy Harp talked about the tree removal process and highlighted that it must go through each local HOA before it comes to her for approval. The same thing applies for changes to any property along golf course border. Kathy Harp and Rick Schram will be shopping for new annuals to add to the planters outside the clubhouse.

# Asset Management:

Director Lee Harker reported that the committee had a walk thru on April 23<sup>rd</sup> with the contractor of the interior remodel of the clubhouse. The Asset Management committee has been working with the CCE committee to discuss the placement of the benches that were purchased for Edith Green Park. There will be new signs ordered for Edith Green Park and the Tot Lot to show park hours.

### Golf Club Liaison:

Director Bubba Heard reported the cart barn should be done by May or early June as they expect the new golf carts to be delivered very soon. The golf course is also working on the remodel of the restrooms throughout the golf course. They will be adding new toilets, sinks, light fixtures, and a fresh coat of paint.

Director David Mauk reported on the valuable resources the City of Wilsonville has to offer on the French Prairie pathway project and the 2040 vision project. David Mauk announced Courtney Neron is running for Oregon State Senator to replace Senator Aaron Woods.
