Standing Committee Reports:

Emergency Preparedness:

Director Bubba Heard moved for approval to accept Jim Teague as a member of the EPPS Committee. The motion was seconded and passed.

Governance Task Force Formation:

The Governance Task Force was formally established with a mandate to examine internal governance and financial metrics. This task force is temporary in nature, has a specific assignment, and has no authority. Members include President Kathy Harp, Vice President David Mauk, Director John McLain, Director Joe Brouillette and General Manager Jim Meierotto.

Vice President David Mauk moved for approval of the formation of this governance task force. The motion was seconded and passed unanimously.

Sports Center Governance:

Director Joe Brouillette provided a detailed overview of the Sports Center's governance challenges, emphasizing the need for a formalized structure to ensure equitable representation and conflict resolution between tennis and pickleball communities.

Vice President David Mauk moved for approval to accept Joe Brouillette's interim role as Chair of the Sports Center Council for governance transition. The Sports Center Liaison role will be dissolved. The motion was seconded and passed.

CVCC Entrance Sign:

Secretary Lindy Anderson presented visuals and recommendations for new entrance signage at the Charbonneau Village Center. The board provided feedback, which will be presented to the CVCC Board for approval before installation.

Reserve Study:

General Manager Jim Meierotto presented the reserve study and budgeting process for both the Country Club and Country Club Estates, focusing on needs while aiming to keep dues increases minimal.

The Country Club <u>reserve study</u> included an 86-cent dues increase to fund \$500,000 in planned improvements, including Clubhouse restroom upgrades, HVAC systems at the Sports Center, and infrastructure maintenance. The Country Club Estates <u>reserve study</u> included a \$2.25 dues increase mostly due to rising pool maintenance costs.

Director Mary Fieweger moved for approval of the 2026 CCC reserve study. The motion was seconded and passed.

Director John McLain moved for approval of the 2026 CCE reserve study. The motion was seconded and passed.

2026 Draft Budget:

General Manager Jim Meierotto presented on the budget and the financial impact that comes with the increased assets and amenities. We are anticipating at this time an increase of \$5-6 per month per household which includes operations projections, capital improvement, and reserve study. The big drivers are reserve study, repairs and maintenance, irrigation, tree work and landscape, electricity, insurance, and security. The board will be voting next month. For Country Club Estates residents, local dues are anticipated to be increasing about \$6 per month per resident.

Public Comment:

An open session commenced, and residents provided their input, questions, and comments to the Board. The Board answered questions and engaged with the residents throughout the public comment session.

Unfinished Business:

Director Bubba Heard moved for approval to add Lee Harker back onto the standing committee list, under Asset Management. The motion was seconded and passed.
